

## Tuition Waivers and Scholarships for International Master in Business (IMB) Candidates

SDA Bocconi Asia Center is strongly committed to supporting outstanding students admitted to its academic programs. Awards offered by SDA Bocconi Asia Center and sponsor companies/institutions provide valuable financial support to ensure that excellent students from all economic and social backgrounds can access a superior level of higher education.

### 1. The Tuition Waivers and Scholarships

**a) Tuition Waivers:** SDA Bocconi Asia Center is offering merit-based tuition waivers up to 80% for the IMB 2023-25 admitted candidates with an outstanding profile. The factors considered here are Academic consistency, Strong entrance test scores, Extracurricular activities, and Outstanding personal interview. The waivers are applied on the tuition fee after deduction of the scholarship (if applicable) only, thus not on the full Admission Fees.

**b) Dean's Scholarship** can be granted to admitted students, based on the Dean's decision only. This scholarship is awarded at the time of selection and disbursed to the students if they manage to be in the top 5% in the class at the end of first 11-month module. Its amount is of INR 2 Lac inclusive of GST, will be adjusted against the payable tuition fee of the second module, and will not be disbursed directly to the student.

**c) Women's Leadership Scholarship** is created with the intention of supporting meritorious women candidates applying to the IMB program. The scholarship amount is INR 2 Lac inclusive of GST and is applied on the tuition fee before the Tuition Waivers. Recipients of the Scholarship are high-potential female candidates who meet our standard selection criteria and exhibit exemplary leadership skills in one or more ways: academic leadership, team leadership, community leadership, sports, and creative leadership.

**d) Sports and Cultural Art Scholarship** can be granted to those students who have been at a consistent high level in any sport (preferably at National level) and any cultural or Art form. The scholarship amount is INR 2 Lac inclusive of GST and is applied on the tuition fee before the Tuition Waivers. The decision of awarding this lies at the discretion of the Scholarship Committee and cannot be challenged. Students must furnish supporting documents as proof along with their documents to be considered for this scholarship

## **2. Beneficiaries and Requirements**

IMB candidates who meet all the following requirements will be taken into consideration:

- Outstanding personal, academic and professional background and high motivation
- Compliance with all the admission requirements for the participation in the IMB

Program. There is no separate application required for the tuition waiver or scholarships. It is evaluated based on your IMB application itself.

## **3. Incompatibility and Assignment of Scholarships**

Tuition waivers can be awarded with any other scholarship, award, or financial support for IMB by public or private organizations or companies if the total amount does not exceed the overall cost of the program (tuition fees). The beneficiary must self-certify that the above-mentioned accumulation has not been exceeded. The beneficiary must comply with this condition for the whole duration of the IMB Program. The right to the tuition waiver and scholarship is subject to the regular completion of the 2023 - 25 IMB Program as indicated in the 2023 - 25 IMB Rules. Tuition waiver can be withdrawn at any time during the program as a penalty for serious disciplinary cases. No two scholarships can be combined. In the calculation of the final fee, scholarships are applied first on the tuition fee and then the tuition waivers as applicable. Admission fee is separate.

## **4. Disbursement**

The final percentage of awarding for each round is at the discretion of the Committee and their decision is final and unquestionable. Students should apply in the earlier rounds to take maximum advantage of these scholarships and waivers.

Please note that the information provided aims to be accurate as far as possible at the time of publication. The school reserves the right to add, withdraw or modify any of the criteria, amount and count for all the tuition waivers and scholarships cited.

## **5. Terms and conditions**

Application for the tuition waiver and scholarships involves full acceptance of the herein conditions.

The candidate must confirm his/her enrolment in the 2023 – 25 IMB (by paying in full the Admission Fee) as well as formalize his/her acceptance of all tuition waiver and scholarship conditions with the Admissions office by the deadline indicated on the offer letter. The students are not allowed to disclose or discuss the amount of Tuition Waiver/Scholarship that they may have received. If not adhered to, it may also lead to revoking the Tuition waiver/Scholarship offer.
